Even if supply is made in more than one lot bill should be raised only once after making full or final supply. Bills for the supply will be paid after the items are received, tested/ inspected/ commissioned and found satisfactory with regard to quality, quantity and specifications ordered for suppliers.

For delay in commissioning beyond 1 month or otherwise mentioned in the P.O. liquidated damages as per Sl. No. 7 may be deducted from the Bill/ Agency Commission.

If a Force Majeure situation arises, the supplier shall promptly notify the purchaser in writing of such conditions and cause thereof. Unless otherwise directed by the purchaser in writing. The supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

The supplier shall not be liable for forfeiture of its performance security, late penalty or liquidated damages or termination for default, if and to the extent that its delay in performance or other failure to perform its obligations under the contract is the result of an event of Force Majeure for purposes of this clause.
