01/2018**

1. Candidates shall report at CSIR-CIMFR, Barwa Road, Dhanbad strictly at 8:30 A.M. on the date of Trade Test.
2. Candidates will be permitted to carry following items with them into the venue :
 - (a) Mask (b) Gloves (c) Personal transparent water bottle (d) Personal Hand Sanitizer
 - (e) Pen (f) Verification related documents in original.
3. All candidates entering through Security entry gate will be compulsorily screened with thermal scanner, any candidate found with symptoms of COVID like high temperature, fever, cold, cough or breathing issues WILL NOT be allowed to enter CSIR-CIMFR.
4. Wearing of face cover/mask is compulsory in CSIR-CIMFR premises and no candidate will be allowed entry without face mask. Social distance must be followed. Candidates shall follow all the guidelines issued by Govt. of India/Govt. of Jharkhand.
5. All candidates should register him/her in "**AROGYA SETU**" mobile application, developed by Govt. of India and may display the app status to security persons at the time of entry.
6. Candidate shall fill Self-Declaration and No Risk Certificate form (enclosed) and submit to the Security at the time of entry.
7. Candidates must follow Security Instructions and maintain physical distancing during their presence in CSIR-CIMFR premises.
8. Smoking and Spitting is strictly prohibited.
9. Candidates must bring the following documents in original along with Call Letter:
 - a) SSLC/Matric/Xth Std Certificate
 - b) SSLC/Matric/Xth Mark sheet
 - c) 10+2/Intermediate/Diploma Certificate
 - d) 10+2/Intermediate/Diploma Mark sheet
 - e) Graduation Certificate
 - f) Graduation Mark sheet (each semester)
 - g) Equivalency certificate issued by Board/Inst./University.
 - h) Experience Certificate
 - i) Certificates in respect of all other educational/professional qualification including experience as mentioned in the application form.
 - j) **Rules/Guidelines issued by the Board./Inst./University for converting CGPA/DGPA/OGPA or any other such grading into percentage of marks.**
 - k) Original Identity proof & Xerox of the same.
 - l) **NOC from the present employer.**

In case the candidate serving under Central/State Govt./Autonomous Body/PSU, **No Objection Certificate** from the present employer to appear for Trade Test will be required to be submitted by them. **If the Permission/No Objection Certificate is not submitted at the time of verification of the documents, the candidate will not be allowed to appear for the Trade Test.**

Candidates will not allowed to be appear for Trade Test if it is found during the verification of documents that he/she is not eligible for the post applied for as per the advertisement.
