TERMS & CONDITIONS

- 1. The coal disposal auction process will be conducted and monitored under the supervision of SIC, Nagpur and members of the *Disposal Committee* formulated for the purpose.
- 2. The EMD cost for the tender is Rs. 1000/-
 - (a) It is mandatory for all interested bidders to submit an EMD, by demand draft (DD) drawn in favour of The Director, CIMFR, Dhanbad from any of the nationalized bank, which can be submitted in prescribed format duly filled in with signature and seal in sealed envelope to this office on or before 01:00 PM of 21.04.2023 (Friday). The bid will be opened on 21.04.2023 at 04:00 PM (Friday) in the presence of all the bidders (only one representative of each bidder) who wish to be physically present.
 - b) The bids without original EMD will be rejected summarily. This EMD is refundable to unsuccessful bidders after the auction process is over.
 - c) Prospective bidders are allowed to visit the site from 05.04.2023 to 18.04.2023, where the proposed coal heap has been piled, during office hours from 11:00 am to 01:00 pm after obtaining permission from SIC or his nominated official.
- 3. Prospective bidders will submit their bid / offer in sealed envelope. The envelope will contain the details of the firm and DD (Demand Draft) to take part in the tendering process as asked in Annexure-I to buy reject coal along with plastic bottles. The participants / interested bidders are required to quote high to complete the bid offered by CSIR-CIMFR
- 4. The bid will be submitted to SIC, Nagpur and kept in his custody till its opening. In case a bidder is successful, by offering highest bid, the bidder has to deposit 25% of the accepted amount through cheque on the spot. In case of failure to do so, his/her EMD will be forfeited.
- 5. No cash will be accepted by CSIR-CIMFR or its representatives at any stage.
- 6. The successful bidder is required to submit the remaining 75% of the accepted bid price in the next seven working days. He/she will be depositing the entire amount to SIC, Nagpur and will present the proof of the same before permission is granted for lifting the auctioned material. If he/she fails to deposit the balance 75% amount within next 07(seven) working days then his/her earlier deposited 25% amount along with EMD can be forfeited by the Competent Authority.
- 7. After the realisation of the cheque, of the auctioned amount (i.e.100% of cost of coal being disposed), SIC Nagpur will issue the award letter to the successful and accepted bidder on behalf of the Director -CIMFR.
 - a) Successful bidder will be arranging his/her transportation and labourers to lift the disposed coal heap within a week time to ten working days after the issue of the award letter. No extension of time will be granted for lifting the coal reject. If an extension is requested on genuine grounds, the same may be granted /rejected by the SIC.
 - b) All the government taxes as applicable and related to this tender will be paid by the successful bidder accepted by CIMFR to whom the award letter for lifting the coal heap is issued.
 - c) Expenses related to toll tax will be borne by the successful bidder.
- 8. While lifting the disposed-off coal material, the successful and accepted bidder should remain cautious not to harm the other property of the institute.
- 9. (a) Director, CSIR-CIMFR Dhanbad is the final decision authority in respect of this bid and reserves the right to accept/reject any or all bids in part or full at any stage.
 - b) SIC reserves the right to finalise the bid on the day of the opening of bid on behalf of Director-CIMFR
- 10. In case of any requirement, the legal jurisdiction will be at Dhanbad. Any dispute, or the issue will be first resolved by Director, CSIR-CIMFR, Dhanbad in consultation with SIC, Nagpur.
- 11. All are requested to maintain discipline and peace at the time of the bid opening. If Anyone is found involved in creating any type of nuisance during the bid opening process, will not be allowed to do so.
- 12. The bidding process will be completed on the same day to select a successful bidder hence, all participants are requested to come prepared with cheques, letter pads, seal (Stamps), etc. for deal finalisation to be done on the same day.
- 13. All the participating bidders should come prepared fully on the date of bid opening for on the spot decision.
- 14. In case, the auctioned coal is not lifted by the successful bidder within 07 (seven) working days, ground rent at the rate of 0.5% of sale value quoted by successful bidder will be imposed.
